I hope this e-mail finds you both well. I've now had an opportunity to review your file as well as some of the documents with respect to your Grenadian estate and tax inquiries. I regret to inform you that I cannot properly advise you on your responsibility for tax arrears or your ability to divest the subject properties as I do not have knowledge of Grenadian law. This task is well beyond the scope of my expertise and I do not feel comfortable (and I would be doing you a disservice) advising you on such matters. I would advise, however, that you attempt to engage legal counsel in Grenada to determine ownership as well as tax arrears and/or other encumbrances that may be owing on these properties.
